At least 20 professionally edited digital photographs will be made available to the Client in a personal online photo gallery with small, web-sized download capabilities ONLY within 14 days of the session. \_\_\_\_\_

1. All payments are due in full at the onset of the session unless payment arrangements have been made. Images will not be processed or delivered to the Client until payment in full is received. \_\_\_\_\_

2. The above mentioned Client is responsible for all extra costs that the Photographer may have for travel, meals, and parking in addition to all other reasonable and customary costs in order to complete this stated contract, and these costs will be discussed and allotted for prior to the photo session. \_\_\_\_\_

3. The \$50 deposit counts toward the total amount of the session (it is not an extra cost), and is non-refundable unless the Photographer does not appear at the agreed location at the date and time specified above, in which case the deposit shall be refunded in full to the Client. In the case of inclement weather, a session may have to be rescheduled at the discretion of the photographer. Re-shoots are also determined at the discretion of the photographer. Re-shoots

and refunds will not be given for poor choices of clothing, make-up, hair or weather related issues, or by not following the recommendations of the photographer. \_\_\_\_\_

4. **The Photographer will choose a minimum of 20 of the highest quality photos from the shoot to edit and upload into a personal online gallery.** These photos can be downloaded by the Client for no extra cost at **web-size** (small files not intended for print). **Large digital files and prints ARE NOT included with the session**, but they are available to purchase at an additional cost. \_\_\_\_\_

5. The client will assist and cooperate with the Photographer in planning and executing the photographs, such as specifying specific location(s) and poses; assisting the Photographer in posing at the Photographer's direction; pre-session consultations, etc. The Photographer is not responsible for photographs that are not taken due to the Client's failure to request them or due to a lack of cooperation or reasonable assistance. \_\_\_\_\_

6. The Photographer keeps the copyright of all photographs and is authorized to use them in the Photographer's promotional material such as a blog, website, or advertisements. If the Client would prefer that photos of their children not be posted online, please discuss it with the Photographer in advance. \_\_\_\_\_

7. Photographer is not responsible for any injuries inflicted upon any participating parties. Client(s) will be responsible for their children and for themselves and release photographer from any claims against their person or their business. \_\_\_\_\_

8. After six (6) months, all images will be purged from photographer's hard-drive, except as needed for promotional purposes, to be determined by photographer at photographer's sole discretion. Photographer is not responsible for loss or damage to the digital files due to circumstances beyond photographer's control. \_\_\_\_\_
